Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Community Safe Deposit Vault Company does not share with nonaffiliates so they can market to you.		
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Community Safe Deposit Vault Company doesn't jointly market
